Along with them, 54 adults who were either unemployed or seeking to change careers also had to take the certification test. There are currently 22 states in the program with a total of 70 counties participating.

Business of the month/volunteer of the quarter – Cele reported that the article for the November business was done and she was working on the volunteer article. The article will come out in the paper and be on the website.
